Before submitting your application for Academic Renewal to Virginia Western Community College, it is important to note the following:

- You must have been separated from the College for a minimum of five years (60 months) in order to receive Academic Renewal.
- Academic Renewal can be granted only one time, and once granted, it cannot be revoked.
- Any course credit with a grade of "D" or "F" earned during the Academic Renewal adjustment period will not count toward your graduation requirements. For example, if you've already completed a curricular requirement and earned a grade of "D" for the course, this course will be excluded from your curriculum and will not count toward graduation after that grade has been forgiven. You will need to retake this course, or another equivalent of this course.
- Although your GPA will be adjusted as a result of Academic Renewal, all grades and courses that were forgiven will remain in your permanent record, and will be reflected with a parentheses () around the grade.
